Instate Tuition Request Form School Year 2023-2024

The parent/guardian of eligible school-age children must complete an *Instate Tuition Request Form* if they are a non-resident requesting their child be admitted into the Lake Oswego School District on a tuition basis.

Approval of admission does not imply that your student can participate in Oregon School Activities Association (OSAA) athletics or activities at the high school level. OSAA regulations apply and should be carefully considered. Parent/guardian is responsible for contacting OSAA.

District guidelines for allowing tuition paying transfers to LOSD schools:

- 1. Space must be available in the grade-level and school requested.
- 2. Transportation is the responsibility of the parent/guardian.
- 3. The District reserves the right to revoke permission for enrollment if the student does not comply with LOSD academic, attendance or behavior guidelines.
- 4. First-time requests may be submitted throughout the year to LOSD. Fall admission requests may not be considered until final enrollments are completed.
- 5. Applications for Instate Tuition must be submitted annually. If an application for renewal of Instate Tuition Request is not completed by the parent/guardian, attendance privileges in LOSD will be discontinued, and the student will be expected to attend school in their resident district.
- 6. The completed application must be submitted by the parent/guardian to LOSD for review and approval by the Executive Director of Elementary and Secondary Operations.
- 7. If the request is denied by LOSD: The parent/guardian shall receive a copy of the written denial, including reason(s) why the request was denied as recorded on the Instate Tuition Request Form.
- 8. If the request is approved by LOSD: The parent/guardian shall receive a copy of the approved Instate Tuition Request Form and a letter stipulating tuition fees and the enrollment agreement.
- 9. Non-resident students in grades 1-12 currently enrolled as tuition-paying students will be eligible for continued enrollment as tuition-paying students.

LOSD admits students to all the rights, privileges, programs and activities generally accorded or made available to all students in the schools. It does not discriminate on the basis of race, color, religion, sex, sexual orientation, gender identity, national origin, marital status, age, or disability in administration of its educational policies, admission policies, athletic programs, or in any other way. This extension of privileges does not apply to the District's fee waiver and reduction program.
